LEGAL CORNER ON PDP LAW

Starting 17 October 2024, all entities controlling or processing the personal data of Indonesian citizens or residents must implement Law 22 of 2022 regarding Personal Data Protection ("PDP Law")

The PDP Law applies to a wide range of entities, including private companies, public institutions, individuals, and international organizations, whether based in Indonesia or abroad, that control or process the personal data of Indonesian citizens or residents, and distinguishes between specific personal data (e.g., health, biometric, and financial data) and general personal data (e.g., name, gender, and citizenship). The law safeguards the rights of Personal Data Subjects, including the right to access, correct, or delete data and the ability to withdraw consent for data processing. Exceptions are made for national security, law enforcement, and public interest. Failure to comply with the PDP Law can result in administrative sanctions, criminal sanctions, or financial penalties, which may include fines of up to 2% of annual revenue

Under the PDP Law, data controllers and processors are subject to strict obligations to ensure the lawful processing and safeguarding of personal data. Data controllers are individuals, entities, or international organizations responsible for determining the purposes and methods of personal data processing. Data Controllers must secure explicit consent from data subjects and ensure that data is processed in compliance with the law. They are accountable for the entire data lifecycle, including acquisition, storage, and disposal. On the other hand, Data Processors are tasked with managing personal data based on instructions from Data Controllers and must adhere to the Data Controller's guidelines, and any actions taken beyond those instructions become the processor's responsibility.

Data Controllers and Processors must appoint competent officials to oversee personal data processing if their activities involve public services, large-scale monitoring that requires regular and systematic monitoring, and large-scale processing of personal data for specific personal data related to criminal offenses. . 
